Dear Berwick Police Department,

I am writing to formally file a complaint and request an investigation into what I believe is a targeted harassment campaign against me. On July 2, 2025, I began receiving multiple unsolicited emails confirming signups for various online services using my personal email address, including Squirt.org, Gay for Good, The Center, Gay Therapy Center, and CourseForParents.com. Please see the attached PDFs of these emails for your reference.

I did not authorize or initiate these signups. I believe someone maliciously used my email address without my consent in an attempt to harass and defame me. In response, I have contacted the organizations involved and requested any data associated with these signups—specifically IP addresses, timestamps, and metadata—to help identify the individual responsible. Unfortunately, I have received limited or no cooperation from these entities.

I am requesting that the Berwick Police Department initiate a formal investigation into this matter, as I believe these actions constitute harassment and unauthorized use of my personal information. I respectfully ask that your department utilize all available investigative tools and resources to help identify the person responsible for these fraudulent signups.

While I have my own suspicions as to who may be behind this, I trust your investigative expertise and prefer to leave the determination of responsibility to your team.

I have attached the relevant email evidence to this message. Please confirm receipt of this complaint and advise me on the next steps I should take to assist with the investigation.

Subject: Additional Evidence: Harassment Update & Key Corroboration

Dear Berwick Police Department,

I am writing to provide an important update to my ongoing complaint regarding harassment and malicious online sign-ups that have used my personal information without my consent.

Today, I received another harassing email confirming a subscription to Squirt.org. The account created in my name used the explicit username "babybitchboy," which I did not create or authorize. This alone is deeply concerning.

While reviewing my records, I made a significant discovery:

- In **Attachment 1**, a text message from December 2021 — directly after I served Marisol with divorce paperwork — shows her calling me "baby bitch boy" verbatim. This exactly matches the username used

to sign me up for Squirt.org.

- In **Attachment 2**, another message from the same timeframe shows Marisol referring to my efforts to document our interactions as my “baby bitch diary.” While not a perfect match, it is extremely close in language and tone, further demonstrating a unique, repeated use of this derogatory phrase by her.

I believe these examples strongly support that Marisol — or someone acting on her behalf — was behind the recent malicious online activity.

Important context about my text message records:

When I reviewed these conversations in my text history from December 2021, I found that only my outgoing messages remain; Marisol’s responses are missing, and I do not know how or why they were deleted.

However, it has been my consistent practice for years to document events in real time by writing down what happened immediately after it occurred. This can be verified through countless other text messages, emails, and records I possess. I wanted to clarify this so you understand why the attached screenshots only show my side of the conversation — they are nonetheless accurate reflections of what happened at the time.

Attachments:

- Attachment 1: Screenshot of text message where Marisol calls me “baby bitch boy” verbatim.
- Attachment 2: Screenshot of text message referring to my documentation as a “baby bitch diary.”
- Attachment 3: Screenshot of the email received today, 7-4-25, from squirt.org which addressed me as “Babybitchboy”. This means whoever maliciously signed me up for this service in an attempt to harrass me, and cause me harm, signed me up under the name “Babybitchboy” which is a name only Marisol herself has called me in the past.

I am prepared to provide complete text logs and any additional supporting evidence you may require. Please let me know if you have questions or if there are any next steps I should take.

Thank you again for your attention and assistance in this matter.

Dear Berwick Police Department,

I am writing to provide an important update to my ongoing complaint regarding harassment and malicious online sign-ups that have used my personal information without my consent.

Today, I received another harassing email confirming a subscription to Squirt.org. The account created in my name used the explicit username "babybitchboy," which I did not create or authorize. This alone is deeply concerning.

While reviewing my records, I made a significant discovery:

- In **Attachment 1**, a text message from December 2021 — directly after I served Marisol with divorce paperwork — shows her calling me "baby bitch boy" verbatim. This exactly matches the username used to sign me up for Squirt.org.
- In **Attachment 2**, another message from the same timeframe shows Marisol referring to my efforts to document our interactions as my "baby bitch diary." While not a perfect match, it is extremely close in language and tone, further demonstrating a unique, repeated use of this derogatory phrase by her.

I believe these examples strongly support that Marisol — or someone acting on her behalf — was behind the recent malicious online activity.

Important context about my text message records:

When I reviewed these conversations in my text history from December 2021, I found that only my outgoing messages remain; Marisol's responses are missing, and I do not know how or why they were deleted.

However, it has been my consistent practice for years to document events in real time by writing down what happened immediately after it occurred. This can be verified through countless other text messages, emails, and records I possess. I wanted to clarify this so you understand why the attached screenshots only show my side of the conversation — they are nonetheless accurate reflections of what happened at the time.

Attachments:

- Attachment 1: Screenshot of text message where Marisol calls me "baby bitch boy" verbatim.

- Attachment 2: Screenshot of text message referring to my documentation as a “baby bitch diary.”
- Attachment 3: Screenshot of the email received today, 7-4-25, from squirt.org which addressed me as "Babybitchboy". This means whoever maliciously signed me up for this service in an attempt to harrass me, and cause me harm, signed me up under the name "Babybitchboy" which is a name only Marisol herself has called me in the past.

I am prepared to provide complete text logs and any additional supporting evidence you may require. Please let me know if you have questions or if there are any next steps I should take.

Please see the attached PDFs of these emails for your reference.

I did not authorize or initiate these signups. I believe someone maliciously used my email address without my consent in an attempt to harass and defame me. In response, I have contacted the organizations involved and requested any data associated with these signups—specifically IP addresses, timestamps, and metadata—to help identify the individual responsible. Unfortunately, I have received limited or no cooperation from these entities.

I am requesting that the Berwick Police Department initiate a formal investigation into this matter, as I believe these actions constitute harassment and unauthorized use of my personal information. I respectfully ask that your department utilize all available investigative tools and resources to help identify the person responsible for these fraudulent signups.

While I have my own suspicions as to who may be behind this, I trust your investigative expertise and prefer to leave the determination of responsibility to your team.

I have attached the relevant email evidence to this message. Please confirm receipt of this complaint and advise me on the next steps I should take to assist with the investigation.

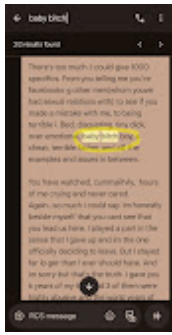

Dear Berwick Police Department,

I am writing to provide an important update to my ongoing complaint regarding harassment and malicious online sign-ups that have used my personal information without my consent.

Today, I received another harassing email confirming a subscription to Squirt.org. The account created in my name used the explicit username "babybitchboy," which I did not create or authorize. This alone is deeply concerning.

While reviewing my records, I made a significant discovery:

- In **Attachment 1**, a text message from December 2021 — directly after I served Marisol with divorce paperwork — shows her calling me "baby bitch boy" verbatim. This exactly matches the username used to sign me up for Squirt.org.
- In **Attachment 2**, another message from the same timeframe shows Marisol referring to my efforts to document our interactions as my "baby bitch diary." While not a perfect match, it is extremely close in

language and tone, further demonstrating a unique, repeated use of this derogatory phrase by her.

I believe these examples strongly support that Marisol — or someone acting on her behalf — was behind the recent malicious online activity.

Important context about my text message records:

When I reviewed these conversations in my text history from December 2021, I found that only my outgoing messages remain; Marisol's responses are missing, and I do not know how or why they were deleted.

However, it has been my consistent practice for years to document events in real time by writing down what happened immediately after it occurred. This can be verified through countless other text messages, emails, and records I possess. I wanted to clarify this so you understand why the attached screenshots only show my side of the conversation — they are nonetheless accurate reflections of what happened at the time.

Attachments:

- Attachment 1: Screenshot of text message where Marisol calls me "baby bitch boy" verbatim.
- Attachment 2: Screenshot of text message referring to my documentation as a "baby bitch diary."
- Attachment 3: Screenshot of the email received today, 7-4-25, from squirt.org which addressed me as "Babybitchboy". This means whoever maliciously signed me up for this service in an attempt to harrass me, and cause me harm, signed me up under the name "Babybitchboy" which is a name only Marisol herself has called me in the past.

I am prepared to provide complete text logs and any additional supporting evidence you may require. Please let me know if you have questions or if there are any next steps I should take.

The texts I provided are an actual, unaltered record of messages I sent directly to Marisol Guerrero (Michaels) in December 2021. In these messages, I described the events as they happened at that time, specifically referencing the moment when Marisol called me a “baby b**** boy.”

I want to be fully transparent: I am unsure why only my texts remain while hers do not. I did not delete any messages from the conversation, and I have no explanation for how her responses disappeared.

Given the distinctiveness of this name and the fact that I am now being signed up for harassing email chains using the exact same phrase, I believe there is no coincidence. Taken together with my lived experience and the broader circumstances of ongoing harassment, this strongly indicates that Marisol is behind these recent, targeted efforts to distress and intimidate me.

p.s. Additional Incident Report

I also wanted to inform you that shortly before sending this email, I received another subscription confirmation email from “Fagabond” (see attached content), a website for LGBT travel. I did not sign up for this mailing list, and it is clear this was done maliciously by someone seeking to harass me.

This incident is part of a pattern of unwarranted, targeted harassment involving my email being signed up for sexually explicit or sexual orientation-themed content. The repeated nature of these sign-ups indicates these are deliberate acts intended to humiliate, distress, and intimidate me by referencing or insinuating sexual orientation.

I believe these actions constitute discrimination based on sex and sexual orientation, as they are being used to degrade and harass me in a manner tied specifically to those protected categories. This is clearly targeted behavior designed to cause me emotional harm.

Additionally, I am a disabled veteran, and if Marisol Guerrero (Michaels) is behind these acts—as the context and prior abuse strongly suggest—she is fully aware of my disability and vulnerabilities, which makes this harassment even more egregious and malicious.

I am providing this information to document the clear pattern of discriminatory harassment I am experiencing and request that it be considered in any investigation or protective actions moving forward. Please let me know if you need further documentation or additional details.

I've attached **the confirmation email screenshot** for your report.

This is part of a **long-standing pattern of harassment** I've documented—through unauthorized signups, harassing texts, and coordinated attacks on my mental health and reputation.

What is particularly alarming now is that for the **past two weeks**, I've also documented **Chelsea Stewart and Christina Coderre—two OCFS employees—regularly monitoring my social media**. This surveillance is **deliberate and sustained**.

It is vital to highlight that **Chelsea Stewart and Christina Coderre were directly involved in my previous child welfare cases**. In fact, they were **two of the most prominent individuals responsible for the decisions and fabricated narratives that led to my current estrangement from my children**. These are the people who **weaponized and cemented false claims against me**, which continue to **haunt my life, destroy my parental rights, and tarnish my reputation**.

I am following up with **MensGroup.com** to request identifying data such as **IP addresses and submission details**, which I will promptly forward to you.

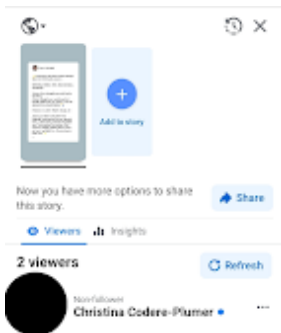

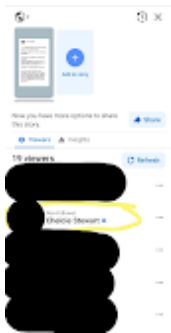

Attached is a screenshot of a confirmation email from a company called **The Whitening Lab**. Someone used my name, phone number, and professional email address (*r.michaels@together-we-grow.org*) to submit a form with the message:

"I need teeth whitening"

This occurred **right after I publicly posted a video calling out the inappropriate, silent monitoring of my social media** by current or former officials from Maine OCFS—including:

- **Chelcie Stewart** (former caseworker)
- **Christina Codere** (her supervisor)
- **Jean Haynes** (who falsely accused me of disorderly conduct and had me no-trespassed from the Biddeford DHHS office on 3/11/25)

The timing and message of this submission are not random. It's clearly meant to **mock me, discredit my appearance, and emotionally retaliate** following my recent public advocacy exposing abuse of power and surveillance misconduct. I did **not** sign up for this service and have never interacted with this business.

Please **add this incident to the report file** as corroborating evidence of a sustained pattern of harassment. The psychological toll is worsening as these targeted acts of humiliation and surveillance continue without accountability.

Subject: Additional Evidence – 3 More Harassing Signups on July 29 & 30

Dear Detective Reil,

I hope you're doing well. I'm reaching out to provide a brief but important update to my ongoing harassment complaint, which you've been actively working on.

In the past two days alone (July 29 and July 30), I received **three more unsolicited signups** using my personal information. These are clearly consistent with the same pattern of malicious, targeted harassment already documented in the case:

1. Plastic Surgery Message (July 29)

I received a highly inappropriate and disturbing SMS from (866) 814-0038 asking me to submit graphic photographs of myself. I've attached a screenshot of this message, which references hashtags like [#southwestplasticsurgery](#) and [#drworldwide](#). I never requested such services, and this appears to be a deliberately humiliating and sexually explicit act meant to demean me.

2. Gaydar Signup (July 30)

I received an unsolicited confirmation email from *Gaydar* at 6:05 PM on July 30, 2025, asking me to verify my email for an account I did not create. Screenshot attached. 

3. Church of Scientology Signup (July 30)

Just minutes earlier, at 6:01 PM on July 30, I also received an email from *Scientology.org*, indicating someone filled out a contact form in my name requesting more information. Again, I did not initiate this. Screenshot attached. 

These incidents are consistent in tone and timing with previous harassing actions—mocking themes around mental health, appearance, sexuality, and now religious affiliation. Each one uses my real name and email address, and some even reference personal data, escalating the invasiveness and severity of the harassment.

I would greatly appreciate it if you could add these three incidents to the open report. Let me know if you need any additional metadata, headers, or information from the source systems—I will gladly provide anything that helps move the investigation forward.

Also, if possible, I'd still like to speak with you by phone or in person at your convenience. I promise to keep it brief and focused—I just want to ensure I've conveyed everything fully and clearly.

Thank you again for your continued attention, diligence, and compassion. Your efforts truly mean more than words can express.

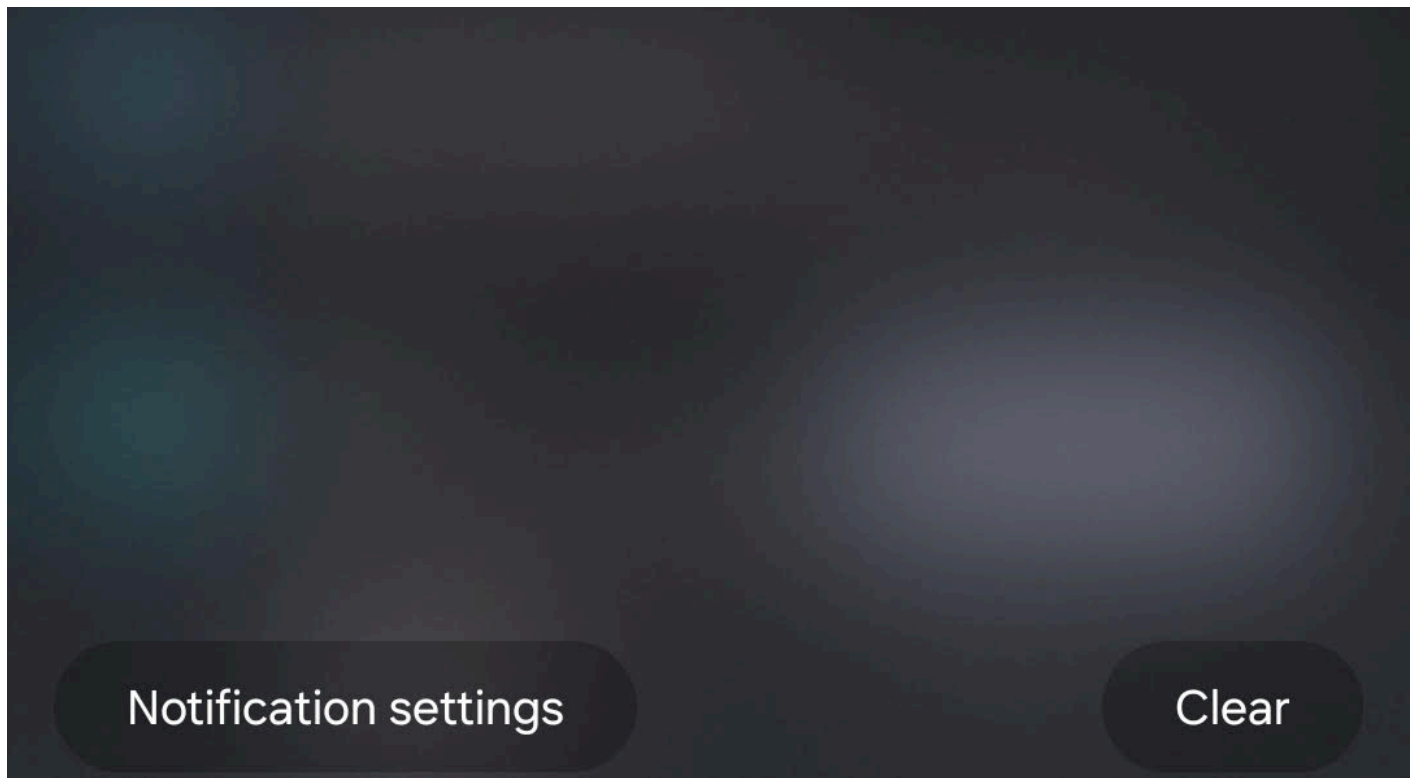
