I am currently facing significant challenges in maintaining contact with my children due to ongoing legal and systemic barriers. Despite court-ordered visitation, my ability to see my children has been obstructed in various ways, and I am seeking a reliable, neutral third-party service that can facilitate these visits in a fair and supportive manner.

A bit about my situation:

Hi Ryan,

I am sorry to hear that you have been having so much trouble. We understand that the legal system can be very difficult to navigate and even more so with a co parent who is not cooperative. To answer your questions, our services are free of charge. Our only two locations are in Brunswick and Lewiston, we do not offer services in Berwick at this time. The documentation that is needed is your most recent court order or agreement that outlines supervised visitation and in order to start services both parents need to complete an intake phone call, and enrollment meeting before Home To Home makes a final decision on whether or not we can accept the family into the program. We do currently have a waitlist at both sites for visitation.

Please let me know if there is anything else I can help you with and best of luck.

Home To Home has a strict no contact policy for participating parents and their representatives accessed through Home To Home. No further communication between parties involving any Home To Home representative or program will be tolerated. I will respond to each party separately. If any communication that I have with either party is shared with the other party, it may not be done in concert with Home To Home staff or programming or it will be considered a breach of this policy.

Home To Home policies prohibit direct and indirect contact between custodial parents or guardians and non-custodial parents and any representative thereof while through any of Home To Home programs and services or while on campus at any visitation site for the purpose of participating in Home To Home Services. These policies are in place to protect all parties and participants to make accessing visitation services safer for all involved. Violations of these policies and procedures could result in termination of visitations and/or services.

Our conversations with you cannot include the other party or their counsel and vice versa. We do not allow contact between parties through our services and programs and that includes email correspondence. This is the second time you have written a group message and while that may be allowed during the legal process, it is not allowed by our program. You included in your first forwarded message your original email to me as well as my response which was then read by the other party and her counsel which could in turn impact your ability to participate in our programming if it is perceived that we are biased in any way. This is a policy to protect both you and the other party from unintended harm.

Hi Annie,

I'm writing to follow up again, as I have not received a response to my previous messages, and I want to be clear and respectful about why I'm reaching out.

On or about October 3rd, during our intake conversation, I was told I was an appropriate fit for the program, including the clinical option. I left that conversation with a clear understanding that we were aligned and moving forward. The only change that occurred afterward was your outreach to the other parent. Following that conversation, I was informed that the program was no longer a viable option, and that you would be reviewing the matter with your clinical consultant and getting back to me with a final decision.

Since then, I have sent multiple follow-up emails seeking clarification and closure, none of which have received a response. I fully respect that my case is being presented as "complex", but given the stakes involved — namely, my ability to have safe, structured contact with my children — I believe it's reasonable to expect clear communication and a definitive response.

I am not writing to argue or place blame. I am asking for transparency and follow-through. If the decision is that Home To Home cannot work with me, I respect that — but I need that decision communicated clearly, along with a brief explanation so I can understand whether the change was based on program capacity, clinical criteria, or information provided by the other parent.

I would appreciate either:

- a final determination regarding my eligibility, or
- a brief update on when I can expect that determination.

Thank you for your time and attention. I hope we can close this loop respectfully and professionally.

Ryan,

Thank you for your patience, I can imagine it has been a frustrating process. Our active families always take priority and we have had several high demand cases over the past 12 months that have required a lot of my time. As a result, we have had limited resources to investigate your case and your case's complexities have taken a significant amount of time to sift through.

I will add that while your communication has been pleasant and polite, it has not served to help speed up our intake process and in many ways held things up because each communication required careful review and further conversation amongst our team. We appreciate your self advocacy and wanted to bring this to your attention so that you may be more successful in the future.

After reviewing your case, speaking with both parties and discussing with our clinician, we have determined that your family's needs are beyond our capacity as an organization. Our organization cannot accommodate your family in either of our programs. We are primarily a grant based program that prioritizes families with active protection from abuse orders. Our clinical program is for families that require clinical intervention and is billed at \$65 per hour with a minimum of 2 hrs billed at a time. We have very limited space in our clinical program and have not had an opening since your inquiry in October.
